

Board of Trustees – Regular Meeting Hussey – Mayfield Memorial Public Library Thursday, November 16, 2023

A regular meeting of the Board of Trustees was held on November 16, 2023, beginning at 5:30 PM.

Kaki Garard - Fundraising Update

Kaki Garard shared that the ARISS grant has been submitted. If funded this grant will allow area school children to speak to an astronaut on the space station. The library should learn about the outcome in December 2023. Kaki also shared that the Friends funded a grant for dipjars to allow patrons/donors to give small amounts via credit card for directed programs. She hopes these are in place for the Secret Snowflake Shop in early December.
