

## Board of Trustees – Regular Meeting Hussey – Mayfield Memorial Public Library Thursday, October 19, 2023

A regular meeting of the Board of Trustees was held on October 19, 2023, beginning at 6:30 PM.

Ed Cambra, Treasurer, presided.

### **SECRETARY** - Minutes

Upon **motion duly made** by Julie Whitman, seconded by Rebecca Carter, and being unanimously approved, the Board of Trustees approved the minutes of the Regular Meeting held September 21, 2023.

# TREASURER - October Claims

Upon **motion duly made** by Rebecca Carter, seconded by Julie Whitman, and being unanimously adopted, the Board of Trustees authorized and directed the payment of the outstanding claims to date for October 2023, as reviewed, approved, and audited by the Director of Operations, and approved for payment by the Treasurer.

Upon **motion duly made** by Julie Whitman, seconded by Chris Squier, and being unanimously approved, the Board of Trustees approved and adopted the 2024 Budget Resolution for Appropriations and Tax Rate. The proposed 2024 budget totals are: \$4,081,686 for the Operating Fund; \$22,150 for the Library Improvement Reserve Fund; \$600,919 for the Bond Repayment Fund; and \$10,637 for the Rainy Day Fund.
